Recycling - fortnightly 1 x 240 litre recycling.

### Rural Areas:

General Waste (Household Putrescible Waste) - weekly 1 x 240 litre bin (red lid).

- The additional service and annual fee will continue until the Mid Murray Council is notified that the service is no longer required and the bin(s) has been removed from the property as identified above.
- The applicant must notify Mid Murray Council in writing if they move premises.
- Solo Resource Recovery reserves the right to refuse the additional bin collection service if the service is not being used correctly.
- Mid Murray Council Waste & Recycling Collection Services Policy forms part of the Conditions.
- Lodgement of an application for an additional bin service and/or use of the waste service constitutes acceptance of the terms and conditions of the service and renders the applicant liable for any fees in connection with the service in the first instance.
