

## **NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961**

I, Christopher Drew Holland, Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act.

I declare that the '2023 Walky 100' is an event to which this section applies and that the following roads be closed to all traffic on Saturday 12 August 2023 between the times as stated below:

## Within the Mid Murray Council and Regional Council of Goyder areas: -

- Range Road, between Tarnma Road and Prior Road
- Prior Road, between Range Road and Pfitzner Road
- Pfitzner Road, between Prior Road and Tarnma Road
- Tarnma Road, between Pfitzner Road and Ngapala Road
- Ngapala Road, between Tarnma Road and Reichelt Road
- Reichelt Road, between Ngapala Road and Julia Road Between 8.00am and 3.00pm
- **Dunstone Road**, between Ngapala Road and Julia Road
- Dunstone Road, between Julia Road and Scenic Road
- Scenic Road, between Dunstone Road and Hills Road
- Garden Road, between Hills Road and Ngapala Road
- Ngapala Road, between Garden Road and Brady Road
- Burra Road, between Brady Road and Werner Road Between 8.15am and 3.30pm
- Von Reiden Road, between Neales Road and Eudunda Road
- Woithe Road, between Von Reiden Road and Neales Road
- Neales Road, between Woithe Road and Foote Road
- Foote Road, between Neales Road and Quondong Road
- Quondong Road, between Foote Road and Neales Road
- Neales Road, between Quondong Road and Brownlow Road Between 1.30pm and 8.45pm
- Rocky Road, between Truro-Eudunda Road and Diagonal Road
- Diagonal Road, between Rocky Road and Heppner Road
- Heppner Road, between Diagonal Road and Levi Road
- Levi Road, between Heppner Road and Frankton Road
- Frankton Road, between Levi Road and Hutt Road
- Hutt Road, between Frankton Road and Watchbox Road
- Watchbox Road, between Hutt Road and Frankton Road
- Frankton Road, between Watchbox Road and North Hills Road
- Frankton Road, between Dutton East Road and Diagonal Road
- Diagonal Road, between Frankton Road and Manor Farm Road
  Manor Farm Road, between Diagonal Road and Frankton Road
- Frankton Road, between Manor Farm Road and Bridge Road
- Bridge Road, between Frankton Road and Habel Street
- Habel Street, between Bridge Road and Dutton Mail Road
- **Dutton Mail Road**, between Habel Street and Rice Street
- Rice Street, between Dutton Mail Road and Truro-Eudunda Road

## Between 1.45 pm and 9.00 pm

- Daveys Road, between Kapunda Road (Thiele Highway) and Tableland Road
- Tableland Road, between Daveys Road and Spring Road
- **Spring Road**, between Tableland Road and Kapunda Road (Thiele Highway) **Between 2.45 pm and 9.15 pm**

I direct that competitors and officials taking part in the '2023 Walky 100' be exempted, in relation to the above closed roads on which the event is to be held, from the duty to observe any enactment, regulation or by-law prescribing a rule to be observed on roads by drivers of vehicles.

I further direct that the event must comply with the following:

- Comply with all Motor Sport Australia requirements
- All closures must be conducted by personnel with the appropriate Work Zone Traffic Management training and utilising approved signage.
- All vehicles participating must be registered and road worthy
- All participants must hold appropriate drivers licence and not be disqualified from driving or from holding a licence in any State or Territory.
- Participants are not exempt from RTA offences related to drink and drug driving.
- Whilst transiting between stages must obey all Australian Road Rules and be road compliant.

I also hereby authorise **Walkerville All Cars Club**, or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

All works to be undertaken must be done so in accordance with the "SA Standards for Workzone Traffic Management" (which calls up the Austroads Guide to Temporary Traffic Management and AS1742.3).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.

The participants undertake the event wholly at their own risk and shall release and indemnify the Police Commissioner for any liability for injury or damage whatsoever inclusive of injury or loss sustained by third parties.
