NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Garreth Lee Jones, Acting Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act.

I declare that the '**2023 Adelaide Hills Rally**' is an event to which this section applies and that the following roads be closed to traffic **between the below listed times and dates**:

SATURDAY 14 OCTOBER 2023

Within the Mount Barker District Council: -

Callington Back Stage

- **Back Callington Road** between Mine Road and Cattle Route Road
- **Cattle Route Road** between Back Callington Road a point south of 256 Cattle Route Road

Between 8.15am and 3.45pm

The Glen Stage

- **Snake Gully Road** between Harrogate Road and Wooley Road
- **Wooley Road** between Snake Gully Road and Jones Road
- **Jones Road** between Wooley Road and Military Road
- **Military Road** between Jones Road and Old Princes Highway

Between 9.00am and 2.30pm

Bugle Ranges Stage

- **Stamps Road** between the event start and Willcox Road
- **Willcox Road** between Stamps Road and Bonython Road
- **Bonython Road** between Willcox Road and Bugle Ranges Road
- **Bugle Ranges Road** between Bonython Road and Stamps Road

Between Midday and 5.30pm

Within the Mount Barker Council and Alexandrina Council: -

Meadows Stage

- **Bald Hill Road** between Bull Creek Road and Mount Ephraim Road
- **Mount Ephraim Road** between Bald Hill Road and Hay Road
- **Hay Road** between Bald Hill Road and Nicol Road
- **Nicol Road** between Hay Road and Bull Creek Road

Between 12.30pm and 6.00pm

Within the Alexandrina Council: -

Strathalbyn Service Park

- **Commercial Road** between Mill Street and Albyn Terrace

Between 11.30am and 5.00pm

Old Bull Creek Stage

- **Old Bull Creek Road** between Archer Court and Spring Gully Road
- **Phillips Hill Road** between Spring Gully Road at the stage start

Between 12.45pm and 6.15pm

SUNDAY 15 OCTOBER 2023

Within the Mid Murray Council: -

Talbot Stage

- **Talbot Road** between Law Road and Black Heath Road
Between 7.20am and 11.20am and between 1.00pm and 5.00pm

Kubenk 1 & 2 Stage

- **Kubenk Road** between Roland Road and Reedy Creek Road
- **Rolland Road** between Kubenk Road and Black Heath Road
Between 7.40am and 11.40am and between 1.20pm and 5.20pm

Pine Hut Stage

- **Pine Hut Road** between Gerschwitz Road and Jutland Road
- **Three Chain Road** at Pine Hut Road
Between 9.36am and 3.06pm

The Gap Stage

- **Gap Road** between Milendella Road and Davenport Road
- **Davenport Road** between Gap Road and Angas Valley Road
Between 10.14am and 3.44pm

I direct that competitors and officials taking part in the '**2023 Adelaide Hills Rally**' be exempted, in relation to a road on which the event is to be held, from the duty to observe any enactment, regulation or by-law prescribing a rule to be observed on roads by drivers of vehicles.

I further direct that the event must comply with the following:

- Comply with all Motorsport Australia requirements
- All closures must be conducted by personnel with the appropriate Work Zone Traffic Management training and utilising approved signage.
- All vehicles participating must be registered and road worthy
- All participants must hold appropriate drivers licence and not be disqualified from driving or from holding a licence in any state.
- Participants are not exempt from RTA offences related to drink and drug driving.

I also hereby authorise the '**2023 Adelaide Hills Rally**' or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

All works to be undertaken must be done so in accordance with the "**SA Standards for Workzone Traffic Management**" (which calls up the **Austrroads Guide to Temporary Traffic Management and AS1742.3**).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.
