

Mid Murray Council meeting update

Council held its last meeting on Tuesday 10 August 2021 at which the following items were discussed or determined:

The following were adopted/endorsed by Council:

- COVID-19 Extraordinary Hardship Relief 2021, waiving of fines for all properties in September 2021 and by application fortnightly payments of the September 2021 instalment to be paid on or before the 10 December (without interest or fines).
- Report on the transfer of Bowhill water entitlements was deferred to 14 September Council workshop.
- Council endorsed submitting the application to SABFAC for the Mannum Waters Marina facility upgrade to the boat ramp and surrounds on behalf of the developer.
- Council authorised the signing and placement of the Council Seal on the Local Government Infrastructure Partnership Program (LGIPP) Deed Agreement for the upgrade of Stage 1 Murraylands Road between Morgan and Blanchetown.
- Council adopted the amended Waste & Recycling Collection Services Policy.
- Council adopted the Transfer Station Access Card disposal discount fee, being 20% of the normal gate fee.
- Council endorsed the final draft Regional Public Health and Wellbeing Plan, and supported its release and submission to the Chief Public Health Officer.
- Council endorsed the declaration for New Year's Eve 2021 Short Term Dry Areas.
- The Representation Review Report to Electoral Commissioner prepared by Norman Waterhouse Lawyers was received and adopted.
- Council adopted the motion to revoke previously held delegations and authorisations of the CEO and adopted new delegations and authorisations in line with changes to current legislation.
- Following a review of the Local Government Association's summary paper: LGA Summary Paper – Round 1 Regulations, Council authorised the Chief Executive Officer to collate Council's feedback and provide a submission to the Local Government Association.
- Council endorsed consent being sought from the Crown, for the rededication of the Morgan Sports Complex to Sport and Recreation.
- Council endorsed the change of location, due to COVID-19 restrictions, from Cadell Institute to the Cambrai Chambers, Main Street, Cambrai, for the 12 October 2021 ordinary meeting.
