NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Senior Sergeant of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister for Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act.

I declare that the '**2023 MSS Safety Rally SA**' is an event to which this section applies and that the following roads be closed to all traffic **between the listed times and dates below:**

Within The Barossa Council and mid Murray Council areas: -

- **Murray Street, Tanunda** between Theodor Street and the Northern Archway
- **Basedow Road, Tanunda** between Murray Street and MacDonnell Street
Between 5.00pm and 9.00pm on Saturday 16 September 2023
- **Pohl Road**, between a point approximately 100 metres south east of the junction with Three Chain Road and Three Chain Road
- **Three Chain Road**, between Pohl Road and unnamed road
- **Unnamed Road**, between Three Chain Road and Pine Crest Road
- **Threes Chain Road**, between Bundilla Road and Pine Hut Road
Between 5.30pm and 10.00pm on Saturday 16 September 2023
- **Pipeline Road**, between Threes Chain Road and Howards Road
- **Howards Road**, between Pipeline Road and Pipeline Road
- **Pipeline Road**, between Howards Road and 3872 Pipeline Road
Between 6.00pm and 10.30pm on Saturday 16 September 2023
- **Jutland Road, Eden Valley** between Rhine Park Road and Church Road
Between 5.30pm and 9.30pm on Saturday 16 September 2023 and between 7.15am and 11.45am on Sunday 17 September 2023
- **Gnadenberg Road, Moculta** between Geisters Road and Keyneton Road
- **Geisters Road**, between Boundary Road and Gnadenberg Road
- **Boundary Road**, between Keyneton Road and Geisters Road
- **Boundary Road**, between Stone Jar Road and Geisters Road
- **Stone Jar Road**, between Hutton Vale Road and Boundary Road
- **Hutton Vale Road**, between Lamb Tail Corner Road and Stone Jar Road
- **Lamb Tail Corner Road**, between Lindsay Park Road and Hutton Vale Road
- **Lindsay Park Road**, between Stott Highway and Lamb Tail Corner Road
Between 6.30pm and 11.00pm on Saturday 16 September 2023 and between 7.45am and 12.15pm on Sunday 17 September 2023
- **Trial Hill Road, Lyndoch** between Barossa Valley Way and Corryton Park Road
- **Corryton Park Road** between Trial Hill Road and Brownes Road
- **Brownes Road** between Corryton Park Road and Heggies Range Road
- **Heggies Range Road** between Brownes Road and Seven Steps Road
Between 6.15am and 1.15pm on Sunday 17 September 2023

- **R Seelinger Road, Flaxman Valley** between Seven Steps Road and Wynns Road
- **Wynns Road** between R Seelinger Road and High Eden Road
- **High Eden Road** between Wynns Road and Springton Road
Between 6.45am and 1.45pm on Sunday 17 September 2023
- **Allendale Road, Kalbeeba** between Balmoral Road and Goldfields Road
- **Goldfields Road** between Allendale Road and Green Gully Road
- **Green Gully Road** between Goldfields Road and Para Wirra Road
- **Para Wirra Road** between Green Gully Road and Humbug Scrub Road
Between 10.00am and 4.00pm on Sunday 17 September 2023
- **Steingarten Road, Rowland Flat** between Barossa Valley Way and Trial Hill Road
- **Trial Hill Road** between Steingarten Road and Tweedies Gully Road
Between 12.30pm and 4.30pm on Sunday 17 September 2023

I direct that competitors and officials taking part in the **'2023 MSS Safety Rally SA'** be exempted, in relation to a road on which the event is to be held, from the duty to observe any enactment, regulation or by-law prescribing a rule to be observed on roads by drivers of vehicles.

The participants undertake the event wholly at their own risk and shall release and indemnify the Police Commissioner for any liability for injury or damage whatsoever inclusive of injury or loss sustained by third parties.

I further direct that the event must comply with the following:

- Comply with all Motor Sport Australia requirements
- All closures must be conducted by personnel with the appropriate Work Zone Traffic Management training and utilising approved signage
- All vehicles participating must be registered and road worthy
- All participants must hold appropriate drivers licence and not be disqualified from driving or from holding a licence in any State or Territory.
- Participants are not exempt from RTA offences related to drink and drug driving
